

Official Rules.

No Purchase Necessary to Enter or Win.

PIN-Based and International Transactions Not Eligible For Automatic Entry.

All entries, whether submitted by using a **consumer** Community Bank of Fitzgerald Debit MasterCard® card (hereinafter, "Card") as described below or by mail, have an equal chance of winning.
