

30 Year Anniversary Sweepstakes

1. Sponsor

Community Banking Company ("Sponsor"), Fitzgerald, Georgia.

4. How to Enter

A. Automatic Entry via Debit Card (No Additional Steps Required)

You will receive **one (1) entry** for each qualifying purchase transaction made using a Community Banking Company consumer debit card during the Promotion Period.

Qualifying Transactions:

- Must be purchase transactions (PIN or signature)
- Must be processed through the Mastercard® U.S. network
- Must post to the account during the Promotion Period

Non-Qualifying Transactions Include:

- ATM withdrawals, cash advances
- Fees (overdraft, maintenance, etc.)
- Returns, reversals, or credits
- Peer-to-peer transfers
- Business debit card transactions
- International transactions
- Any transaction deemed unauthorized, fraudulent, or disputed

B. Free Alternate Method of Entry (AMOE)
